Dear Investor or Creditor:

I am writing to you in connection with the above-referenced action of *Securities and Exchange Commission v. Onix Capital LLC, et al., Case No. 16-CV-24678-Cooke/Torres* (the “SEC Action”), in which the U.S. District Court for the Southern District of Florida entered the attached *Receivership Order*, which, among other things, appointed me as Receiver of Defendant Onix Capital, LLC (“Onix Capital”) and Relief Defendants Deep Ocean, LLC, Next Cab Ventures, LLC, Next Call Ventures, LLC, Next Chat Ventures, LLC, Next Pay Ventures, LLC, Next Track Ventures, LLC, Next U Ventures, LLC, and Progressive Power, LLC (collectively, Relief Defendants”). The U.S. District Court also entered the attached *Sealed Order Granting Securities and Exchange Commission’s Emergency Motion for Asset Freeze and Other Relief*, pursuant to which all assets of Onix Capital, the Relief Defendants and Defendant Alberto Change-Rajii (“Chang”) have been frozen. And, the U.S. District Court has entered Judgments of Permanent Injunction and Other Relief as to Defendants Onix and Chang.

Among my duties as Receiver of Onix and the Relief Defendants are my duties to “[m]arshal and safeguard all such assets and take whatever actions necessary for the protection of any investors of Onix and/or Relief Defendants” and to “[t]ake immediate control and possession of all assets located within the United States belonging to or in possession of [Onix] and Relief Defendants . . . situated anywhere in the United States, and to administer such assets as is required in order to comply with the directions contained in this [Receivership] Order.” And I am required to seek approval of the U.S. District Court before I seek to liquidate any of the assets of Onix or the Relief Defendants.

Once I have secured all known assets of Onix and the Relief Defendants, I will evaluate those assets, confer with the Securities and Exchange Commission, and propose to the U.S. District Court the disposition of assets that I believe is in the best interest of all investors and creditors of Onix and the Relief Defendants.

I will be filing with the U.S. District Court periodic status reports regarding the Receivership and my efforts to, among other things, marshal and secure the assets of Onix and the Relief Defendants. I will post those reports on the website I have created for this Receivership: www.OnixReceivership.com. That website will also include other important Court filings and additional information regarding the Receivership and the underlying SEC Action, including the answers to frequently asked questions. I encourage you periodically to visit this website, which I will update throughout the course of the Receivership and the SEC Action.

Please contact our office upon your receipt of this letter to provide us information regarding your investment or loan to Onix or any Relief Defendant. If you do not reach me directly, please contact my legal counsel Kenneth Dante Murena, Esq.

Please understand that neither I nor any of my attorneys or other representatives may provide you with legal, tax and/or accounting advice regarding this or any other matter. Should you require such advice, I would urge you to contact your own attorney, accountant or other professional.
